# Individual Sporting Policy and Application form



### PURPOSE

The aim is to provide assistance will be provided to assist individuals to participate and engage in higher level sporting activities and be afforded the opportunity to be successful and supported to reach their full potential. Assistance is available for individuals who have been selected to represent a sporting code at an association, regional, state or national-level competition where there is a clear pathway to achieve at the highest possible level.

Sporting grants for gifted athletes (International level) is available for registered members but will be considered Exceptional Individuals and Leadership Development.

### WHO CAN APPLY?

- FWCAC registered member
- Aboriginal people currently living in the Native Title Determination area for at least 10 years.
- Any person who is the primary carer of a FWCAC eligible child under the age of 18 years.

### WHAT TYPES OF MATTERS MAY BE FUNDED?

- Travel expenses for individuals selected to represent their region, state and/or nation.
- Accommodation will only be supported if travel for the event is more than 350kms from your registered address.
- Participants, parents and/or care givers are expected to contribute towards the cost of travel and event.

This application is capped at \$300 per event per child with a total capped of \$1,000 per family per financial year

### WHAT TYPES OF MATTERS WILL NOT BE FUNDED?

- Any application received by a person applying on behalf of a FWCAC eligible child, and the applicant is not the primary carer of that child.
- Individual applications to attend State Aboriginal sporting carnivals (events held annually) including budgies netball, nunga next gen carnivals, Maralinga cup.
- Participation in local sports competitions.
- Player registration costs
- Self-identification documentation and or passports
- Self nominations to participate in events including but not limited to Masters games, Auskick half time games at an AFL game
- Overseas travel insurance to attend representative sport
- School sanctioned events such as SAPSASA, Tcharkuldu Rock etc should be applied under the education application.
- Capital Items
- No hire vehicles, taxis, and Uber services will be funded.
- Vehicle repairs, insurance and registration or vehicle mileage for travel

- Food, alcohol, gambling or tobacco products
- Reimbursement of costs already paid by or on behalf of the applicant.
- Direct payment of cash/bank deposit to individuals

### MANDATORY CRITERIA

In considering and assessing applications, the Far West Coast Aboriginal Corporation requires applicants to meet all the mandatory criteria set out in its FWC Application for Assistance Funding Policy.

- This application is restricted to applicants residing in South Australia only.
- Provide proof of selection for individuals participating in regional, state and national events.

### APPLICATION REQUIREMENTS

Applications for funding must:

- Be in writing and in the approved form as provided by the Far West Coast Aboriginal Corporation.
- Be submitted in person, to the mailbox or email address on the application form.
- Identify any other funding that has been accessed or applied for.
- Be submitted at least 2 weeks prior to the event to allow FWCAC sufficient time to process the application. Applications should be submitted as soon as notification is received for the event.
- Address the mandatory criteria outlined in the policy.

### POLICY GUIDELINES

- Where other agencies have specialised responsibilities to provide funding, FWCAC staff may redirect members to those agencies for assistance.
- The FWCAC board sets an annual budget per policy once the expenditure has exceeded its annual allocation, funding assistance may be declined.
- Applications will be subject to the policy and funding criteria at the time the application is lodged.
- FWC funding is a contribution toward the cost, not necessarily the whole cost.
- All travel arrangements will be made by FWCAC staff using the most cost effective arrangements for FWCAC
- Payment is made to suppliers only.


